In accordance with KRS 164.945 - .947 and 13 KAR 1:020, this is to confirm that **Beckfield College – Florence’s** conditional license with respect to the Associate of Applied Science in Magnetic Resonance Imaging (MRI) program (CIP code 51.0920) is hereby extended to May 1, 2027.

The licensure of this program remains conditioned upon the institution submitting to CPE quarterly updates regarding its progress toward obtaining full approval with the Accrediting Bureau of Health Education Schools (ABHES), and submitting to CPE once received final approval documentation from ABHES.

This current conditional license is valid through May 1, 2027, at which time CPE will need to determine if an additional extension may be issued if the institution has not obtained full ABHES approval by that date.

Once CPE receives assurance that Beckfield College – Florence has satisfied these conditions, CPE will remove the institution from conditional license status with regard to this program. A conditional license may not exceed two (2) years. Failure to satisfy the conditions in that time frame may result in revocation of the institution’s license for this program. An extension of the conditional license may be granted upon request of the institution with supporting justification.
